

RESOLUTION NO. 11-02-2020A

NOTICE OF ELECTION

CITY OF DEL CITY

BE IT RESOLVED BY THE City Council of the City of Del City that a nonpartisan election will be held for the purpose of electing officers of said Del City that:

1. A primary election shall be held on Tuesday, February 9, 2021, and
2. A general election shall be held on Tuesday, April 6, 2021, and
3. The primary election and general election shall be nonpartisan.

BE IT FURTHER RESOLVED that the following offices to be filled are:

COUNCILPERSON: Ward 2, Full Four-year Term – voting by Ward.

COUNCILPERSON: Ward 4, Full Four-year Term – voting by Ward.

BE IT FURTHER RESOLVED that to be qualified for the office of Councilperson, each candidate for a City office shall be a qualified elector of the City, at least 25 years of age and have resided in the town and/or city or in territory annexed thereto for at least one year immediately prior to the closing of the filing period; and the further qualification that the Mayor or Councilperson shall have resided within their respective ward a period of one year at the time of their election.

BE IT FURTHER RESOLVED that any qualified person may have his or her name placed on the ballot by filing with the secretary of the Oklahoma County Election Board during the filing period as follows:

Filing Period shall open 8:00 a.m., Wednesday, December 7, 2020, and extend through 5:00 p.m., Friday, December 9, 2020.

BE IT FURTHER RESOLVED that the County Election Board shall conduct said election, pursuant to Title 26, Oklahoma Statutes, Section 13-101 through Section 13-112.

BE IT FURTHER RESOLVED that absentee ballots will be provided pursuant to law.

BE IT FURTHER RESOLVED that on the dates of the elections, the polls as designed by the Oklahoma County Election Board shall remain open continuously from 7:00 a.m. to 7:00 p.m.
